| EXPLANATION: On December 21, 2015, the Forsyth County Board of Commissioners authorized the County to enter into a Reimbursement Agreement with Wexford Winston-Salem Bailey, LLC for public infrastructure development as part of the Bailey Power Plant redevelopment and appropriated \$3,000,000 in the General Fund for this project. The \$3,000,000 was appropriated in the FY 2015-2016 budget, however, an agreement was not executed by the end of the fiscal year and the funds were not encumbered. The unencumbered funds returned to committed fund balance in the general fund on June 30, 2016.
