

## RESOLUTION AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS TO APPLY FOR A LOAN AND/OR GRANT FROM THE STATE OF NORTH CAROLINA TO DEVELOP WASTEWATER COLLECTION AND DRINKING WATER DISTRIBUTION SYSTEMS FOR THE IDOLS ROAD BUSINESS PARK

WHEREAS, the Federal Clean Water Act Amendments of 1987 and the North Carolina Water Infrastructure Act of 2005 (NCGS 159G) have authorized the making of loans and grants to aid eligible units of government to finance the cost of construction of wastewater treatment works, wastewater collection system, stream restoration, stormwater treatment, drinking water treatment works, and/or drinking water distribution system or other "green" projects; and

WHEREAS, Forsyth County owns and is developing the 169 acre tract of land on Idols Road near Clemmons, N.C. into a business park; and

WHEREAS, Forsyth County has need for and intends to construct a wastewater collection system and a drinking water distribution system for the Idols Road Business Park; and

WHEREAS, Forsyth County will be providing the public infrastructure to the business park and plans to sell the lots therein to companies wishing to locate and operate within the park; and

WHEREAS, Forsyth County intends to request State loan and/or grant assistance for the said project;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute, on behalf of Forsyth County, necessary documents to apply for a loan and/or grant from the State of North Carolina to develop wastewater collection and drinking water distribution systems for the Idols Road Business Park.

**BE IT FURTHER RESOLVED** that Forsyth County will arrange financing/funding for all remaining costs of the project, if approved for a State loan and/or grant award.

**BE IT FURTHER RESOLVED** that Forsyth County will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funding for proper operation, maintenance, and administration of the systems and the repayment of all principal and interest on the proposed loan.

**BE IT FURTHER RESOLVED** that Forsyth County agrees to include in the loan agreement with the State a provision authorizing the State Treasurer, upon failure of the County to make scheduled repayment of the loan, to withhold from the County any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

**BE IT FURTHER RESOLVED** that Forsyth County will provide for efficient operation and maintenance of the proposed project upon completion of construction thereof.

**BE IT FURTHER RESOLVED** that the County Manager is hereby authorized to execute and file an application on behalf of Forsyth County with the State of North Carolina for a loan and/or grant to aid in the construction of the project described above.

BE IT FURTHER RESOLVED that the County Manager is hereby authorized and directed to furnish such public information as the appropriate State agency may request in connection with such application or the project, to make the assurances as contained above, and to execute such other documents as may be required in connection with the loan or grant application.

**BE IT FURTHER RESOLVED** that Forsyth County has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, and ordinances applicable to the project and to Federal and State grants and loans pertaining thereto.
