WHEREAS, on August 31, 2015, Forsyth County formally designated the Piedmont Triad Regional Council as its lead area agency on aging for State fiscal years 2017 and 2018 to complete the work and responsibilities of planning and coordinating the development of the County funding plan for local service agencies for the elderly; and

WHEREAS, the Piedmont Triad Regional Council has successfully served in this role and is willing to continue to carry the responsibilities of lead area agency on aging for Forsyth County.
