SUMMARY OF INFORMATION:

The Forsyth County Department of Public Health requests authorization to execute necessary documents to receive a grant from the Kate B. Reynolds (KBR) Charitable Trust in the amount of \$418,193 to support the continued operation of the School Sealant Project implemented by the Cleveland Avenue Dental Center and the Winston-Salem/Forsyth County School System. The School Sealant Project was previously funded by a KBR Operating Grant awarded to the Dental Center in 2014.

The KBR grant will fund staff salary and fringe benefits for time spent on the project, dental equipment and supplies, educational materials, and Project Giveaway Bags given to each child that participates. The Project will provide screening, cleaning and sealant placement for eligible children in Title I Elementary Schools. In-school treatment will be available to any child that returns a signed parental consent form.
