#### RESOLUTION AUTHORIZING THE SALE AT PUBLIC AUCTION OF CERTAIN SUPRLUS COUNTY MOTOR VEHICLES (GENERAL SERVICES DEPARTMENT)

WHEREAS, Forsyth County owns certain motor vehicles and equipment that are no longer useful to the County and are surplus to the County's needs, and the County wishes to dispose of them by sale at public auction;

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners, on behalf of Forsyth County, as follows:

- 1. Pursuant to the provisions of N.C.G.S. 153A-176, 160A-266, and 160A-270, the Fleet Manager is hereby authorized to dispose of the motor vehicles or equipment described in the attached list, which is incorporated herein by reference, at public auction upon the following terms and conditions:
  - A. The sale shall be at public auction to the highest bidder and payment must be made on the date of the sale by cash or check. Any bid may be rejected at the sale if the bid is below the current scrap value of the vehicle or equipment or for any other reason which the Fleet Manager determines to be in the best interest of the County.
  - B. The sale shall be held on Saturday, October 13, 2018, at 10:00 a.m. at the Forsyth County Fleet Surplus Lot, located at 1200 Fairchild Drive in the City of Winston-Salem, N.C.
- For items sold at public auction, this resolution or a notice summarizing its contents, sufficient to comply with N.C.G.S. 160A-270 shall be published at least once and not less than ten days before the date of the auction.
- This resolution shall be effective upon adoption.
