RESOLUTION AUTHORIZING EXECUTION OF A CONTRACT BETWEEN FORSYTH COUNTY AND ARCHANGELS TRANSIT, INC., FOR NON-EMERGENCY MEDICAL TRANSPORTATION (NEMT) SERVICES (FORSYTH COUNTY DEPARTMENT OF SOCIAL SERVICES)

WHEREAS, on September 28, 2015, the Forsyth County Board of Commissioners adopted a resolution authorizing execution of an agreement between Forsyth County and Triad Transportation, Inc., for non-emergency medical transportation services for DSS clients; and

WHEREAS, the Forsyth County Department of Social Services administers this agreement, and the North Carolina Department of Health and Human Services makes all payments to providers of non-emergency medical services for DSS clients; and

WHEREAS, on September 26, 2018, Archangels Transit, Inc., bought the assets of Triad Transportation, Inc.;

BE IT RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County and its Department of Social Services, the attached contract between Forsyth County and Archangels Transit, Inc., for the provision of Non-Emergency Medical Transportation (NEMT) services to Medicaid-eligible recipients provided during the period November 1, 2018 through June 30, 2019, subject to a pre-audit certificate thereon by the Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney. The original contract is incorporated herein by reference (Contract Control #2019-0250-00).

BE IT FURTHER RESOLVED that the County Manager is hereby authorized to execute, on behalf of Forsyth County, amendments to this Agreement for these services with this Provider within budgeted appropriations in the current fiscal year, subject to a pre-audit certificate thereon by the Chief County Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
