RESOLUTION AUTHORIZING QUANTUM MERUIT PAYMENT TO LAW ENFORCEMENT SERVICES GROUP, PLLC FOR PRE/POST HIRE MEDICAL AND PSYCHOLOGICAL TESTING SERVICES (FORSYTH COUNTY SHERIFF'S OFFICE)

WHEREAS Law Enforcement Services Group, PLLC, (d/b/a The FMRT Group) has provided the pre-hire and post-hire psychological and medical assessment services to the Forsyth County Sheriff's Office;

WHEREAS Forsyth County had a contract with Law Enforcement Services Group, PLLC, at a not-to-exceed amount of \$35,000 for Fiscal Year 2019;

WHEREAS the County amended this contract by \$9,000 to increase the not-to-exceed amount for Fiscal Year 2019 to \$44,000; and

WHEREAS the Sheriff's Office requested services in excess of the not-to-exceed amount by \$1,110, for which Law Enforcement Services Group, PLLC, has not been compensated;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby approves the purchase of pre-hire and post-hire psychological and medical assessment services for use by the Forsyth County Sheriff's Office;

BE IT FURTHER RESOLVED, that the Forsyth County Board of Commissioners hereby acknowledge that pre-hire and post-hire psychological and medical assessment services have been provided by Law Enforcement Services Group, PLLC, during fiscal year 2019 at a cost exceeding the contract amount by \$1,110, for which Law Enforcement Services Group, PLLC, has not been compensated by Forsyth County;

BE IT FURTHER RESOLVED, that the Forsyth County Board of Commissioners hereby authorizes payment by Forsyth County in the amount of \$1,110 to Law Enforcement Services Group, PLLC, for pre-hire and post-hire psychological and medical assessment services during fiscal year 2019 on the basis of quantum meruit for the reasonable and just value of services rendered and acknowledged as a benefit to Forsyth County and for which the County received the benefits with the expectation of payment being made for services; and

BE IT FURTHER RESOLVED, that the County Chief Financial Officer is hereby authorized and directed to make payment as provided herein to Law Enforcement Services Group, PLLC, based upon accepted written documentation submitted by the said provider.
