# FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO FY 2019-2020 GRANT PROJECTS ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: October 24, 2019

#### **EXPLANATION:**

On September 12, 2019, the Forsyth County Board of Commissioners adopted a resolution authorizing execution of necessary documents to apply for and receive U.S. Department of Justice, Bureau of Justice Assistance, 2019 Edward Byrne Memorial Justice Assistance Grant (JAG) Funds and authorizing execution of an Interlocal Agreement between Forsyth County and the City of Winston-Salem for use and distribution of the 2019 Edward Byrne Memorial Justice Assistance Grant (JAG) Program Award Funds in the amount of \$187,021. The grant funds have now been officially awarded by the Bureau of Justice Assistance.

The County's portion of the grant is \$93,510.50 and the City's share of the grant is also \$93,510.50. The County will administer the grant and reimburse the City for allowable and eligible expenditures. No local matching funds are required. This grant expires on September 30, 2022.

The purpose of this Grant Projects Ordinance Amendment is to appropriate the 2019 Edward Byrne Memorial Justice Assistance Grant (JAG) Funds, in the amount of \$187,021, into the Justice Assistance Grant Projects Ordinance.
