WHEREAS the Forsyth County Board of Commissioners proposes to adopt the attached Forsyth County Board of Commissioners' Meeting Schedule for 2020 for its regular Board meetings and briefing sessions;

NOW, THEREFORE, BE IT RESOLVED, that the Forsyth County Board of Commissioners hereby adopts the attached Meeting Schedule for 2020, which is incorporated herein by reference, and that Board meetings and briefing sessions will be held in the County Commissioners Meeting Room on the fifth floor of the Forsyth County Government Center located at 201 North Chestnut Street, Winston-Salem, North Carolina, and the Board directs the Clerk to the Board of County Commissioners to provide such notice of the Meeting Schedule as set forth hereinabove.
