FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2020-2021 BUDGET ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: September 10, 2020

EXPLANATION:

At the July 2, 2020, meeting, the Board of Commissioners approved an amendment to the Fiscal Year 2020-2021 Budget Ordinance to appropriate \$247,500 from the Kate B. Reynolds Charitable Trust to support local COVID-19 response and mitigation. These funds were actually received prior to June 30, 2020, so the Board action on July 2, 2020, should have appropriated these funds from Fund Balance rather than Kate B. Reynolds Charitable Trust.

This action is necessary to correct the action on July 2, 2020, so that these funds can actually be used to complete COVID-19 testing, provide community education and outreach, acquire personal protective equipment, and complete other programs, initiatives, and purchases deemed necessary for COVID-19 relief by the Department of Public Health.

BE IT ORDAINED BY THE FORSYTH COUNTY BOARD OF COMMISSIONERS THAT THE FISCAL YEAR 2020-2021 BUDGET ORDINANCE IS HEREBY AMENDED AS FOLLOWS:
