### RESOLUTION RATIFYING THE AMENDED FORSYTH COUNTY PAY PLAN

WHEREASpursuant to N.C.G.S.153A-92 the County Manager is responsible for preparing the Forsyth County Pay Plan for submission to the Forsyth County Board of Commissioners and for administering the Pay Plan in accordance with general policies and directives adopted by the Board, and the Board is responsible for approving Pay Plan, including the schedule of pay, and other compensation of all county officers and employees;

WHEREAS due to high turnover of Emergency Services staff and a large number of vacancies in EMT and Paramedic positions, the Director of Emergency Services, Human Resources Director, and County Manager recommend a mid-year PayPlan adjustment for EMT, Paramedic, and supervisory employees of the Forsyth County Emergency Medical Services System in an effort to address recruitment and retention efforts among Emergency Medical Technicians and Paramedics; and

WHEREAS the recommended adjustment would result in a one pay grade increase for the EMT and Paramedic classifications and benchmarking of relevant supervisory positions and also includes full implementation of a 5% per grade increase as well as an additional 5% increase for eligible employees with relevant educational degrees or National Registry Certification within the department, which would result in the following Pay Plan for the affected employees:

# FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2020-2021 BUDGET ORDINANCE

#### **EXPLANATION:**

Due to high turnover of Emergency Services staff and a large number of vacancies in EMT and Paramedic positions, the Director of Emergency Services, Human Resources Director, and County Manager recommend a midyear Pay Plan adjustment for EMT, Paramedic, and supervisory employees of the Forsyth County Emergency Medical Services System in an effort to address recruitment and retention efforts among Emergency Medical Technicians and Paramedics.

The recommended adjustment would result in a one pay grade increase for EMT and Paramedic classifications and benchmarking of relevant supervisory positions. The recommendation includes full implementation of 5% per grade increase, and includes an additional 5% increase for eligible employees with relevant educational degrees or National Registry Certification within the department.

The total implementation cost of this adjustment, based on an implementation of October17, 2020, will be \$542,402.99. The annualized cost associated with the adjustments will total \$723,203.99 in recurring costs.
