RESOLUTION DECLINING FIRST OPPORTUNITY TO OBTAIN PROPERTY AS OFFERED BY THE WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION AND REQUESTING THE PROCEEDS OF THE SALE BE APPLIED TO REDUCE THE COUNTY'S BONDED INDEBTEDNESS (0.015 ACRE PORTION OF THE SOUTHWEST CORNER OF THE EAST FORSYTH MIDDLE SCHOOL PROPERTY)

WHEREAS, by resolution adopted on the 20th of August, 2013, the Winston-Salem/Forsyth County Board of Education proposes to accept an offer made by the North Carolina Department of Transportation to purchase a 0.015 acre portion of the southwest corner of the East Forsyth Middle School Property to further develop the eastern section of the Winston-Salem Northern Beltway, for the amount of \$250.00, subject to the first opportunity to obtain the property by the Forsyth County Board of Commissioners and further subject to compliance with the procedures prescribed by N.C. General Statutes, Chapter 160A, Article 12; and

WHEREAS, N.C.G.S. 115C-518 provides that the board of education, holding title to any real property which is no longer suitable or necessary for public school purposes, which proposes to dispose of said property, shall offer the property to the board of county commissioners for the county in which the property is located at a fair market price or at a price negotiated between the two boards; and

WHEREAS, N.C.G.S. 115C-518 further provides if the board of county commissioners does not choose to obtain the property as offered, the board of education may dispose of the property as provided by law and the proceeds shall be either applied to reduce the county's bonded indebtedness for the school administrative unit or for capital outlay purposes; and

WHEREAS, the Forsyth County Board of Commissioners does not desire to purchase the above described real property from the Winston-Salem/Forsyth County Board of Education; however, the Forsyth County Board of Commissioners does desire that the proceeds of the sale of the subject property be applied to reduce the County's bonded indebtedness;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the provisions of N.C.G.S. 115C-518, the Forsyth County Board of Commissioners hereby declines the opportunity to purchase the 0.015 acre portion of the southwest corner of the East Forsyth Middle School Property as offered by the Winston-Salem/Forsyth County Board of Education; and the Forsyth County Board of Commissioners hereby requests that the proceeds of the sale of the subject property be applied to reduce the County's bonded indebtedness.

At its meeting on August 20, 2013, the Winston-Salem/Forsyth County Board of Education approved, subject to the Forsyth County Commissioners right of first refusal pursuant to N.C.G.S. § 115C-518(a), the sale of 0.015 acres of land on the southwest corner of East Forsyth Middle School to the North Carolina Department of Transportation. The Board's Resolution is enclosed.

The Board of Education has determined that this portion of land is not necessary for public school purposes. The North Carolina Department of Transportation will use the 0.015 acres to further develop the eastern section of the Winston-Salem Northern Beltway. The NC DOT will pay the Board of Education \$250.00 for the 0.015 acres. This will leave 39.985 acres remaining with access to Bagley Drive and Aviary Court.

BACKGROUND INFORMATION:

The North Carolina Department of Transportation, has offered to purchase 0.015 acres on the southwest corner of property owned by the Board of Education at East Forsyth Middle School. The parcel will be used for the eastern section of the Northern Beltway (future I-74). The NC DOT will pay the Board of Education \$250.00 for the 0.015 acres. This will leave 39.985 acres remaining with access to Bagley Drive and Aviary Court.

Pursuant to N.C.G.S. § 115C-518, the Board must first determine that the property is no longer suitable or necessary for public school purposes. N.C.G.S. § 115C-518(a) also requires the Board of Education provide to the Board of County Commissioners of Forsyth County a right of first refusal to purchase the property prior to conveyance to the NC DOT.

The attached Resolution authorizes the Board of Education to agree to the attached Summary Statement/Offer to Purchase Real Property subject to the County's right of first refusal pursuant to N.C.G.S. § 115C-518(a).

SUPERINTENDENT'S RECOMMENDATION:

That the Board of Education provides to the Board of County Commissioners the statutory right of first refusal to purchase the parcel of property located at East Forsyth Middle School, and, in the event the right is not exercised by the County, agree to the attached Summary Statement/Offer for the NC DOT to purchase the property.

RESOLUTION OF THE WINSTON-SALEM/FORSYTH COUNTY BOARD OF EDUCATION

WHEREAS, the Winston-Salem/Forsyth County Board of Education owns real property on a 40 acre site commonly known as East Forsyth Middle School;

WHEREAS, the North Carolina Department of Transportation has offered to purchase 0.015 acres of the 40 acre plot;

WHEREAS, the 0.015 acre portion of land on the southwest corner of the East Forsyth Middle School property is not necessary for public school purposes;

WHEREAS, the North Carolina Department of Transportation will use the 0.015 acres of land to further develop the eastern section of the Winston-Salem Northern Beltway;

WHEREAS, N.C.G.S. § 115C-518(a) requires the Board of Education provide to the Board of County Commissioners of Forsyth County a right of first refusal to purchase property before it can be sold.

WINSTON-RESOLVED THE HEREBY IT THEREFORE, \mathbf{BE} SALEM/FORSYTH COUNTY BOARD OF EDUCATION as follows:

- 1. That the 0.015 acres identified for purchase by the NC Department of Transportation is not necessary for public school purposes;
- 2. That, pursuant to N.C.G.S. § 115C-518(a), it provide the Board of County Commissioners of Forsyth County a right of first refusal to purchase the property; and
- 3. That, subject to the approval of the Forsyth County Commissioners pursuant to N.C.G.S. § 115C-518(a), it accepts and agree to the sale of property to the North Carolina Department of Transportation.






