SUMMARY OF INFORMATION:		
On December 17, 2012, the Forsyth County Board of Commissioners authorized the Forsyth County Cooperative Extension Services staff to apply for a grant from the North Carolina Department of Agriculture and Consumer Services, Agricultural and Development and Farmland Preservation Trust Fund to develop a Forsyth County Farmland Protection Plan.		
The Forsyth County Cooperative Extension Service received notification of a \$14,000 grant to be used towards the development of a Farmland Protection Plan. The grant requires a \$4,200 County match which will be made through in-kind services, and no additional County funds or positions are required for this grant.		
The purpose of this agenda item is to authorize execution of the grant agreement and to amend the FY 2013-2014 Budget Ordinance to appropriate the \$14,000 to NC Cooperative Extension Service to be used to contract with a provider to develop the Farmland Protection Plan.		
The grant period is from July 1, 2013 to June 30, 2015.

RESOLUTION AUTHORIZING EXECUTION OF A GRANT AGREEMENT WITH THE NORTH CAROLINA DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES, AGRICULTURAL DEVELOPMENT AND FARMLAND PRESERVATION TRUST FUND FOR THE DEVELOPMENT OF A FORSYTH COUNTY FARMLAND PROTECTION PLAN (FORSYTH COUNTY COOPERATIVE EXTENSION SERVICE)

WHEREAS, on December 17, 2012, the Board of Commissioners of Forsyth County adopted a resolution authorizing the Forsyth County Cooperative Extension Service to submit a grant application in the amount of \$15,000 to the North Carolina Department of Agriculture and Consumer Services, Agricultural Development and Farmland Preservation Trust Fund for the development of a Forsyth County Farmland Protection Plan, during the grant period July 1, 2013 through June 30, 2015; and

WHEREAS, the Forsyth County Cooperative Extension Service received notification from the North Carolina Department of Agriculture and Consumer Services approving a \$14,000 grant for said project;

NOW, THEREFORE, BE IT RESOLVED that the Forsyth County Board of Commissioners hereby authorizes the Chairman or County Manager and Clerk to the Board to execute the necessary grant documents, on behalf of Forsyth County, and its Cooperative Extension Service, to receive the \$14,000 grant from the North Carolina Department of Agriculture and Consumer Services, Agricultural Development and Farmland Preservation Trust Fund for the development of a Forsyth County Farmland Protection Plan, subject to a pre-audit certificate thereon by the Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
