WHEREAS, after due advertisement, proposals were received at 12:00 noon, Tuesday, May 13, 2014 in response to Forsyth County's Request for Proposals, to provide janitorial services for the Forsyth County Hall of Justice building, located at 200 North Main Street, Winston-Salem and the following proposals based on annual cost were received:

WHEREAS, the proposal submitted by American Facilities Services, Inc. failed to meet all requirements of the Request for Proposals and cannot be considered for award; and

WHEREAS, it is the recommendation of the County Manager, the Forsyth County General Services Director, and the Purchasing Director that a contract to provide janitorial services for the Forsyth County Hall of Justice building be awarded to The Budd Group, Inc., in the annual amount of \$166,968 for an initial contract period of one year, commencing July 1, 2014 and ending June 30, 2015, with the option to extend the contract at the same annual cost, for up to two additional one-year terms, provided that both parties are in agreement and funds are available for this purpose; and

WHEREAS, the County Chief Financial Officer has determined that sufficient funds are available to cover the cost of this contract.

NOW, THEREFORE, BE IT RESOLVED by the Forsyth County Board of Commissioners, that a contract to provide janitorial services for the Forsyth County Hall of Justice building is hereby awarded to The Budd Group, Inc., in the annual amount of \$166,968 for an initial contract period of one year, commencing July 1, 2014 and ending June 30, 2015; and that all other proposals are hereby rejected.

BE IT FURTHER RESOLVED that Forsyth County reserves the right to extend the contract at the same annual cost, for up to two additional one-year terms, provided that both parties are in agreement and funds are available for this purpose.

BE IT FURTHER RESOLVED that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with The Budd Group, Inc., consistent with the terms of the RFP issued by the County, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
