RESOLUTION AUTHORIZING EXECUTION OF AN AMENDMENT TO AGREEMENT BETWEEN FORSYTH COUNTY AND DENTAL POWER INTERNATIONAL, INC. FOR TEMPORARY DENTIST SERVICES FOR THE PUBLIC HEALTH DENTAL CLINIC (DEPARTMENT OF PUBLIC HEALTH)

BE IT RESOLVED by the Forsyth County Board of Commissioners that the Chairman or County Manager and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County and its Department of Public Health, the attached contract amendment between Forsyth County and Dental Power International, Inc., which increases the contract amount from \$49,500 to not to exceed \$74,500, for temporary dentist services at the Public Health Dental Clinic, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney. The original contract is incorporated herein by reference.

Amendment to Dental Power / Dentist Placement Advantage Client Agreement

As of May 7, 2014, the contract entitled Dental Power / Dentist Placement Advantage Client Agreement, between Dental Power International, Inc. ("Dental Power") and Forsyth County shall be amended as follows:

In Section 3. <u>Locum Tenens Service Fees</u>, the language stating "\$103.00 per hour (with an 8 hour per day minimum billing). Services for this Agreement shall not exceed \$49,500.", shall be replaced with the following:

"\$103.00 per hour for a dentist within 50 miles of the work location and \$106.50 per hour for a dentist more than 50 miles from the work location (Client is not billed for commuting time), both with an 8 hour per day minimum billing, except for scheduled half days. Services for this Agreement shall not exceed \$74,500."

All other terms and conditions shall remain unchanged.
