FORSYTH COUNTY, NORTH CAROLINA AMENDMENT TO 2015-2016 BUDGET ORDINANCE

FROM: BUDGET & MANAGEMENT MEETING DATE: October 26, 2015

EXPLANATION:

Mental illness and substance abuse issues are prevalent in many detainees at the Forsyth County Law Enforcement Detention Center (LEDC). The National Association of Counties has worked with other groups to raise awareness of the factors contributing to the over-representation of people with mental illnesses in jails and to develop practices and strategies to reduce these numbers.

On April 27, 2015, the Forsyth County Board of Commissioners adopted a resolution supporting the Stepping Up Initiative to reduce the number of people with mental illness in jails. As part of this commitment, this Budget Ordinance Amendment appropriates funds to establish a temporary part-time position to study the Forsyth County Law Enforcement Detention Center population and assess ways to better identify adults entering the LEDC with mental illnesses and to develop a plan with measurable outcomes to address the issue of mental illness in the LEDC. This study will also determine which programs and services are available in the county for people with mental illnesses and co-occurring substance use disorders.

The goal for completion of this study is nine months, at which time, a report will be issued to the Forsyth County Board of Commissioners.

BE IT ORDAINED BY THE FORSYTH COUNTY BOARD OF COMMISSIONERS THAT THE FISCAL YEAR 2015-2016 BUDGET ORDINANCE IS HEREBY AMENDED AS FOLLOWS:

STEPPING UP: FORSYTH COUNTY'S RESPONSE TO A NATIONAL CALL TO ACTION TO REDUCE THE NUMBERS OF PEOPLE WITH MENTAL HEALTH AND/OR SUBSTANCE ABUSE IN JAIL

BACKGROUND

The National Association of Counties (NACo), the Council of State Governments (CSG) Justice Center, and the American Psychiatric Association Foundation (APAF) have come together to lead a national initiative to help advance counties' efforts to reduce the number of adults with mental and co-occurring substance use disorders in jails. With support from the U.S. Justice Department's Bureau of Justice Assistance, the initiative will build on the many innovative and proven practices being implemented across the country...

On April 27, 2015, the Forsyth County Board of Commissioners passed a resolution to support Stepping Up: A National Initiative to Reduce the Number of People with Mental Illnesses in Jails. This an initiative of the NACo CSG Justice Center and APAF which was formally launched in May 2015 is a Call to Action for strong county and state leadership and a shared commitment to a multi-step planning process that can achieve concrete results for jails in counties of all sizes. Specifically, county elected officials were asked to pass work with other leaders (e.g., the sheriff, judges, district attorney, treatment providers, and state and local policymakers), people with mental illnesses and their advocates, and other stakeholders to reduce the number of people with mental illnesses in jails.

PROJECT DESCRIPTION

We propose to conduct community-focused research to produce the Stepping Up: Action Plan to reduce the number of people with mental illnesses in the Forsyth County jail.

Methodology

Within the study a variety of methodologies will be incorporated to provide a comprehensive picture of mental health and substance abuse (MH/SA) issues facing persons in jail in Forsyth County.

GOALS & OBJECTIVES

The main goal of the project is to generate and implement a plan for the Forsyth County Step Up Initiative with knowledge of the population of Forsyth County PIJ/MH/SA and available behavioral health care resources and current barriers to the utilization of those resources.

- 2. Establish a baseline of the rates of persons in jails with mental illnesses and their recidivism risk.
- Generate a service map/director that identifies the programs and services are available in the
 county for people with mental illnesses and co-occurring substance use, disorders, and identify
 state and local policy and funding barriers to minimizing contact with the justice system and
 providing treatment and supports in the community.
- 4. Develop a plan with measurable outcomes that draws on the needs and prevalence assessment data and examination of available treatment and service capacity, while considering identified barriers.
- 5. Implement research-based approaches that advance the plan.
- 6. Create an initiative evaluation plan.
- 7. Share lessons learned with other counties in North Carolina and across the U.S.
