# RESOLUTION AUTHORIZING SUBMISSION OF A LETTER OF COMMITMENT TO PARTICIPATE AS A US52 CORRIDOR BROWNFIELD COALITION PARTNER IN AN ENVIRONMENTAL PROTECTION AGENCY (EPA) BROWNFIELD ASSESSMENT COALITION GRANT

WHEREAS, the Piedmont Triad Regional Council (PTRC) is seeking municipal and county US52 Corridor Brownfield Coalition Partners, to participate in a proposed three-year, \$600,000 Environmental Protection Agency (EPA) Brownfield Assessment Coalition Grant; and

WHEREAS, the grant will enable PTRC to continue building a regional brownfields assessment and redevelopment program for communities throughout the Piedmont Triad, in partnership with its local government members, the NC Brownfields Program and EPA; and

WHEREAS, PTRC is in the process of writing the grant proposal, and invites proposed initial partners within the US52 Corridor to provide a letter of commitment to participate in the coalition; and

WHEREAS, if the region's application is approved, funding will begin October 1, 2016 and PTRC will manage and administer the program as it has done over the past two years with its current coalition assessment grant for communities in the Business 85 (29/70) Corridor from Lexington to Greensboro resulting in several projects receiving letters of intent to purchase and redevelop upon completion of the assessment and clean-up planning; most projects receiving membership in the NC Brownfields Program and becoming eligible to receive assistance in development of a letter of agreement with the Department of Environment and Natural Resources (DENR) to remove liability from non-contributing prospective developers and returning brownfield properties to productive use;

**NOW, THEREFORE, BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby authorizes submission of a letter of commitment to participate as a US52 Corridor Brownfield Coalition Partner in a proposed three-year Environmental Protection Agency (EPA) Brownfield Assessment Coalition Grant in the amount of \$600,000.

BE IT FURTHER RESOLVED that the Chairman, County Manager, City/County Planning and Development Director, and Clerk to the Board are hereby authorized to execute, on behalf of Forsyth County, the attached letter of commitment to participate as a US52 Corridor Brownfield Coalition Partner in an Environmental Protection Agency (EPA) Brownfield Assessment Coalition Grant, subject to a pre-audit certificate by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.

## PIEDMONT TRIAD BROWNFIELDS PROGRAM

#### The Ask

The Piedmont Triad Regional Council (PTRC) is seeking municipal and county US52 Corridor Coalition Partners, to participate in a proposed 3-year, \$600,000 Environmental Protection Agency Brownfield Assessment Coalition Grant. The grant will enable PTRC to continue building a regional brownfields assessment and

redevelopment program for the Piedmont Triad, in partnership with its local government members, the NC Brownfields Program and EPA.

#### What's a Brownfield?

Any real property - the expansion, reuse or redevelopment of which - may be complicated by the presence or potential presence of environmental contamination.

#### The Purpose


The PTRC Brownfields Program facilitates the assessment and cleanup planning of idled or underused sites and provides

strategic investments to stimulate the redevelopment of mills, gas stations, vehicle repair facilities, dry cleaners, and other potential brownfield sites. Catalyst projects are intended to improve quality of life, increase tax base and create jobs while protecting public

health and the environment. Emphasis will be given to areas posing the most risk to human health and the environment, yet with the most potential for redevelopment and reuse.

#### The Process

Initial program efforts will be focused on identifying brownfield sites in communities along the US52 corridor in Mount Airy, Pilot Mountain, King, Tobaccoville, Rural Hall and Winston-Salem - and the 3 Counties in which they are located - Surry, Stokes and Forsyth. Top priority sites may be eligible to receive funding for Phase I and II Environmental Site Assessments. Sites with the greatest potential for redevelopment may also receive funding for assistance with clean-up and re-use planning, membership in the NC Brownfields Program, and the development of a Letter of Agreement with the NC Department of Environment and Natural Resources, to remove liability from noncontributing prospective developers.
