**SUBJECT: RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION TO THE N.C. DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, DIVISION OF ENVIRONMENTAL ASSISTANCE AND CUSTOMER SERVICE (DEACS) FOR A GRANT THROUGH THE CONVENIENCE CENTER COMMINGLED RECYCLING COLLECTION GRANT PROGRAM  
(OFFICE OF ENVIRONMENTAL ASSISTANCE AND PROTECTION)**

**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:** Recommend Approval

**SUMMARY OF INFORMATION:**

The N.C. Department of Environment and Natural Resources, Division of Environmental Assistance and Customer Service (DEACS) is offering grants for the direct purchase of compacting roll-off systems that will be used to collect commingled residential recyclable materials from the public. Both self-contained compacting roll-off systems and stationary compacting roll-off systems using detachable roll-off receiver boxes are eligible for grant funding support.

Grant funding is only available for jurisdictions that operate staffed convenience centers or other staffed drop-off sites collecting recyclable materials from the public. The Forsyth County Office of Environmental Assistance and Protection (OEAP) requests permission to apply for grant funding totaling \$30,000 to support the purchase of two (2) compacting roll-off systems (cost \$15,000 per compacting system) to be placed at the Hanes Mill Recycling Drop-off site and the Kernersville Recycling Drop-off site. There will be approximately \$4,000 in additional costs not covered by the grant to cover the total cost of the compacting systems and for signage.

There is the expectation with these systems to reduce the number of recycling pickups at these two very busy sites thereby reducing monthly costs for recycling services.

There is no local match required for this grant.

**BE IT RESOLVED** that the Forsyth County Board of Commissioners hereby authorizes the submission of an application, on behalf of Forsyth County and its Office of Environmental Assistance and Protection, to the N.C. Department of Environment and Natural Resources, Division of Environmental Assistance and Customer Service (DEACS) for a grant through the Convenience Center Commingled Recycling Collection Grant Program.

**BE IT FURTHER RESOLVED** that the Convenience Center Commingled Recycling Collection Grant application will total \$30,000 to support the purchase of two (2) compacting roll-off systems (cost \$15,000 per compacting system) to be placed at the Hanes Mill Recycling Drop-off site and the Kernersville Recycling Drop-off site.

**BE IT FURTHER RESOLVED** that the County Manager is hereby authorized to execute, on behalf of Forsyth County and its Office of Environmental Assistance and Protection, any necessary documents to submit the said Convenience Center Commingled Recycling Collection Grant application to the N.C. Department of Environment and Natural Resources, Division of Environmental Assistance and Customer Service, subject to a pre-audit certificate thereon by the County Chief Financial Officer, where applicable, and approval as to form and legality by the County Attorney.
