Healthy Communities Program initiatives in our community include the Healthy Corner Store Program, Project Lazarus, Falls Prevention (Matter of Balance classes) and Tobacco-free Multi-unit Housing workshops. The additional funds will be used to support staff salaries and benefits, program supplies and materials, and staff training and conference.
