**Meeting Minutes**

**March 15, 2024 – 11:00 a.m.**

**Meeting Called to Order**

A meeting of the Forsyth County Board of Elections was called to order in the 2<sup>nd</sup> Floor Board Room on Friday, March 15, 2024, at **11:16** a.m., Chairperson Robert Durrah, Jr. presiding.

### **Board Challenges of Absentee Voters**

1. Director Tsujii presented to the Board that Emily Hrabovsky was a same-day registration voter who attempted to change party affiliated, however, the February 9, 2024 deadline to change a voter registration had already passed. Secretary Doomy moved to sustain the voter registration challenge; Member Draper seconded. **Motion carried unanimously.**
2. Director Tsujii informed the Board that Brandon Fitzgerald Brooks was a same-day registration voter but who is still on probation for a felony conviction and his rights have not been fully restored at this time. Secretary Doomy moved to sustain the challenge; Vice Chair Jourdan seconded. **Motion carried unanimously.**
3. Director Tsujii informed the Board that Anthony Brooks was a same-day registration voter but who is still on probation for a felony conviction and whose rights have not been fully restored at this time. Secretary Doomy moved to sustain the challenge; Member Draper seconded. **Motion carried unanimously.**

### **Report on Hand-to-Eye Audit**

Deputy Director Michelle Bobadilla presented to the Board that a bipartisan team performed the hand-to-eye audit. The State Board of Elections randomly selected two precincts, 304 and 075, for the audit. Mrs. Bobadilla explained that the sample audit count is required by statute and helps ensure the reliability of election results tabulated by a machine. The audit is a comparison of the machine counts with hand-to-eye counts completed as a test to ensure voting equipment read the voter's choices accurately. Mrs. Bobadilla reported that no discrepancies were found. Member Draper moved to accept the hand-to-eye audit; Secretary Doomy seconded. **Motion carried unanimously.**

### **Report on Audit and Reconciliation**

Adam Clark, Elections Systems Manager, presented to the Board the Vote History Audit and Reconciliation Report, which showed a 0.016 % discrepancy margin. Secretary Doomy moved to accept the report on audit and reconciliation as submitted; Vice Chair Jourdan seconded. **Motion carried unanimously.**

1. Director Tsujii presented that two same-day registration voters had their voter registration cards marked undeliverable and per Senate Bill 747 within the new law the registrations are to be denied. Secretary Doomy moved to deny the two voter registrations; Member Draper seconded. **Motion carried unanimously.**
2. Director Tsujii presented that a voter at the Rural Hall early voting site was issued the wrong voter ballot style and accidentally inserted the balloted in the tabulator before the new ballot was issued. Secretary Doomy moved to discount the inappropriate tabulated balloted; Vice Chair Jourdan seconded. **Motion carried unanimously.**
3. Director Tsujii presented to the Board a letter from County Commissioner David Plyler which stated his withdrawal from candidacy for the fall 2024 general election. Chairperson Durrah called for a motion of acknowledgement for receipt of the letter. Member Draper moved to accept the resignation withdrawal letter from Commissioner Plyler; Vice Chair Jourdan seconded. **Motion carried unanimously.**

**Recess:** Chairperson Durrah called for recess at 11:58 a.m.

**Reconvene:** Chairperson Durrah reconvened the meeting at 12:05 p.m.

### **Certification of the 2024 Primary Election**

Director Tsujii presented to the Board that there was no additional information to report regarding the certification of the 2024 primary election results.

Member Draper moved to approve the drafted plan of early voting sites as submitted; Secretary Doomy seconded. **Motion carried unanimously.**
